

## NOTICE TO BIDDERS

**GTAC PROCUREMENT MEASURES FOLLOWING THE REGULATIONS ISSUED IN THE GOVERNMENT GAZETTE PUBLISHED ON THE 18<sup>TH</sup> MARCH 2020 IN TERMS OF SECTION 27(2) OF DISASTER MANAGEMENT ACT, 2002 AND THE NATIONAL LOCKDOWN AS ANNOUNCED BY THE PRESIDENT OF SOUTH AFRICA ON 23 MARCH 2020 DUE TO THE COVID-19 GLOBAL PANDEMIC.**
